RECOMMEND TO THE ASSOCIATION'S RESPECTIVE BOARDS TO COOPERATE WITH LOS ANGELES COUNTY PUBLIC WORKS ON THE PREPARATION AND SUBMISSION OF GRANT

APPLICATIONS FOR THE CULVERTS PROJECT

RECOMMENDATION:

Staff recommends that the Commissioners of the AVSWCA (Association) approve recommending to the Association's respective boards to cooperate with Los Angeles County Public Works on the preparation and submission of grant applications for the Culverts Project.

BACKGROUND:

Staff has been in discussions with Los Angeles County Public Works (L.A. County) staff and their consultants to identify potential grant funding opportunities for culvert installations that will reduce flooding on roadways and enable improved recharge at Big Rock, Littlerock, and Upper Amargosa Creeks. Culverts are being proposed along West Avenue N in Palmdale, along East Palmdale Boulevard in Littlerock, and along East Avenue T and East Avenue S in Pearblossom / Llano.

Two grant funding opportunities have been identified for the Culverts Project (Project). The first is the Bureau of Reclamation's WaterSMART Drought Resiliency Program which focuses on water storage capacity that increases surface water or groundwater storage. This program has a maximum project cost of \$10 million with a 50% cost share. A notice of funding for Fiscal Year (FY) 2025 for this program was posted on July 24. Applications are due by October 7, 2024.

The WaterSMART Small Storage Program is another grant program that aligns well with the Project. This program has a maximum \$30 million project cost with a 25% cost share. Applications for the second round of funding from this program are due on April 30, 2025. The Project may qualify for a disadvantaged communities cost share waiver.

With support and cooperation from AVSWCA, L.A. County staff has agreed to work with their consultants to prepare and submit grant applications to the WaterSMART Program for this multi-benefit Project and would cover the costs associated with application preparation. Time is of the essence to begin working on an application package for the Drought Resiliency Program to meet the deadline of October 7, 2024. L.A. County has requested that the Association or one of its respective agencies be placed as lead agency

on this application for the purpose of limiting competitive conflicts as L.A. County may apply for funding under this program for other public works projects.

If the Association approves, a recommendation would be made to its respective boards to individually consider approving working with L.A. County to prepare and submit grant applications for the WatersMART Programs. This item is presented with a sense of urgency with respect to the short time frame to apply for 2025 FY funding from the Drought Resiliency Program.
